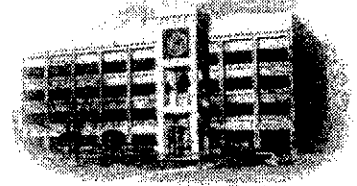



**PETITION FOR CLEANING OUT, RELOCATING, WIDENING, DEEPENING,
STRAIGHTENING, TILING, EXTENDING, OR RELOCATING
ALONG A HIGHWAY, ADDING BRANCHES, AND/OR INSTALLING, MAINTAINING
OR REPAIRING STRUCTURES OR MECHANICAL DEVICES
FOR AN INTERCOUNTY DRAIN**

TO THE DRAINAGE BOARD OF THE
MISTEGUAY CREEK INTERCOUNTY DRAIN DRAINAGE DISTRICT

Petitioner hereby petitions for cleaning out, relocating, widening, deepening, straightening, tiling, extending or relocating along a highway, adding branches, and/or installing, maintaining or repairing structures or mechanical devices to the drain known and designated as the Misteguay Creek Intercounty Drain, located and established in Shiawassee, Genessee and Saginaw Counties, a portion of which is located in Albee Township, Saginaw County, Michigan.


Petitioner is Albee Township and this petition has been authorized by its governing body, as evidenced by the attached resolution. The petitioner is a municipality which will be liable to assessments at large for at least a percentage of the total amount to be assessed for the cost of the proposed drain project.

Your petitioner further shows that the said drain needs cleaning out, relocating, widening, deepening, straightening, tiling, extending or relocating along a highway, adding branches, and/or installing, maintaining or repairing structures or mechanical devices to the drain for the following reason(s):

DIKE EROSION

and said cleaning out, relocating, widening, deepening, straightening, tiling, extending or relocating along a highway, adding branches, and/or installing, maintaining or repairing structures or mechanical devices to such drain is necessary and conducive to the public health, convenience or welfare of Albee Township.

At a Regular meeting of the Township Board for Albee Township, held in said Township, Saginaw County, Michigan, on April 13, 2010, at 8 o'clock, p.m.

PRESENT: Turnwald, Gasser, Kulhanek, Briggs

ABSENT: Wasmilller

The following resolution was offered by Gasser and seconded by Kulhanek

WHEREAS, Albee Township recognizes that it is necessary for the public health, convenience and welfare to maintain, and improve the Misteguay Creek Intercounty Drain pursuant to Chapter 8 of Public Act 40 of 1956, as amended; and

WHEREAS, lands to be benefited by the maintenance and improvement of the Misteguay Creek Intercounty Drain are within Albee Township and other municipalities within Shiawassee, Genessee and Saginaw Counties; and

WHEREAS, the Township recognizes that it will be subject to assessment to pay for a percentage of the costs of the Drain at large.

NOW, THEREFORE BE IT RESOLVED THAT, pursuant to Chapter 8 of Public Act 40 of 1956, as amended, a petition for cleaning out, relocating, widening, deepening, straightening, tiling, extending, adding branches, relocating along a highway, and/or installing, maintaining or repairing structures or mechanical devices to the Misteguay Creek Intercounty Drain is authorized to be executed by Albee Township, and that the Supervisor and Township Clerk are authorized to sign all documents necessary to effectuate the intent of this petition.


BE IT FURTHER RESOLVED that the Township Clerk shall forward to the Saginaw County Drain Commissioner a copy of this resolution and file the petition to perform maintenance and improvement, including the adding of branches of the Misteguay Creek Intercounty Drain, as permitted under Public Act 40 of 1956, as amended.
