

PETITION FOR LOCATING, ESTABLISHING AND CONSTRUCTING
A DRAIN OR DRAINS OR ANY PORTION THEREOF

To the County Drain Commissioner of the County of Genesee.

Your petitioners respectfully show that they are freeholders in the Drainage District as Laid Out and Designated in your order of March 11, 2011 in the County of Genesee, State of Michigan in which said District the PINE LAKE OUTLET DRAIN, #1689 or any part thereof, herein applied for is to be LOCATED, ESTABLISHED and CONSTRUCTED.

Your petitioners respectfully declare that they constitute a number of freeholders in said Drainage District whose lands would be liable to an assessment for benefits equal to one-half of the number of freeholders whose lands would be traversed by the drain or drains applied for, or abut on the part of any highway or street along either side of which such drain extends between the point where such drain enters such highway and the point where it leaves such highway.

Also that LOCATING, ESTABLISHING AND CONSTRUCTING of said Drain or Drains or any part thereof, will be conducive to the public health, convenience and welfare.

Your petitioners therefore make petition, and hereby respectfully ask you to LOCATE, ESTABLISH AND CONSTRUCT a drain or drains, or any portion thereof, which will properly drain the lands in said district, under the provision of Act No. 40 of the Public Acts of 1956, the location of said drain or drains, or any portion thereof, as given in your order for Laying out and designating the PINE LAKE OUTLET DRAIN, #1689 Drainage District, to be substantially as follows

Beginning at a point in Pine Lake that is S87°40'59"W, 1763.97 feet along the North Line and S04°02'32"E, 812.83 feet from the North corner of Section 33 of T5N, R6E, Fenton Township, Genesee County MI; thence S82°04'02"E, 267.31 feet; thence S33°37'12"E, 53.33 feet; thence S61°45'05"E, 286.74 feet; thence S67°11'42"E, 315.35 feet to Silver Lake and the Point of Ending


